Getting There

Hyatt Regency Washington on Capitol Hill is located in the heart of the distinctive Capitol Hill neighborhood. You will find that the hotel is also a ten-minute walk from the famous National Mall, home to dozens of renowned monuments and free museums. Less than 2 blocks away is historic Union Station, offering an impressive variety of shopping, dining, entertainment and transportation alternatives.

The hotel is near the Union Station subway stop (red line), bringing the best of the capital area to your door, it's about an 8-minute walk to the hotel. It is also 15 minutes from Ronald Reagan National Airport. Approximate cost to the hotel is \$2.50 (by Metro) and \$25.00 (by taxi). Parking at the hotel is \$62 per day.
